## ADDITIONAL COURSES

**Class II (transite or floor tile removal) 8 Hour class 9:00a.m. - 5:00p.m. \$160.00** Any asbestos-related work that does not involve removal of pipe insulation, boiler wrap (TSI) or surfacing ACM (fireproofing, sprayed on ceilings). Examples: wallboard, floor tile & sheeting, gaskets, joint compounds, roofing felts, roofing & siding shingles. Removal of less than approx. 3 Sq./3 lin. Ft. of these materials can be considered Class III work.

**Class III (Maintenance workers) 16 Hour class 9:00a.m. - 5:00p.m. \$250.00**

Repair and maintenance operations which are likely to disturb Asbestos Containing Material (ACM) or Presumed Asbestos Containing Material (PACM). "Disturbance" means activities that disrupt the matrix of ACM or PACM, crumble or pulverize ACM or PACM, or generate visible debris from ACM or PACM. Operations may include drilling, abrading, cutting a hole, cable pulling, crawling through tunnels, or attics and spaces above the ceiling where asbestos is actively disturbed or asbestos-containing debris is actively disturbed. Removal of less than 3 Lin./3 Sq. Ft. of pipe insulation to repair a leak, valve, etc. would be a Class III work.

**ClassIV(Custodial) 2 Hour class \$80.00 (groups are discounted)**

Cleaning up ACM waste, debris, and dust due to a construction activity. Examples are debris from drilling, abrading, cutting a hole, running cables above a suspended ceiling, sweeping, mopping, dusting, cleaning, and vacuuming of asbestos containing materials, dust and/or debris. Stripping and/or buffing of an ACM floor tile can also be considered Class IV work, if done incidental to construction work.

**MOLDSAFEWORKPRACTICES 8 hour-\$160.00 (groups of more than 5)**

This course is a 1-day (8 hour) course for workers who have completed the 4-day asbestos worker course. This class is specific to hazard awareness, work practices and personal protection. We present this class with a video, slide, and lecture format.

**MOLD SAFE WORK PRACTICES 16 hour - \$250.00 (groups or more than 5 are discounted)**

We also offer a 2-day (16 hour) course for persons who have no training in respirators or establishing controlled areas. This is one day of classroom training and one day of hands-on training. The additional day teaches basic OSHA requirements for using respirators and building negative pressure environments.
